

# Miss Fountain City Scholarship Rules

If awarded a scholarship in the 2010 Miss Fountain City Pageant, I agree to the following:

1. I will provide the Director of the Miss Fountain City Pageant with a letter accepting my scholarship no later than August 25, 2009 mailed to: Miss Fountain City Pageant, 101 W. Main Street, Prattville, AL 36067. If I have not selected a college by that date, I understand that I must still send a request letter stating that college information will be provided NO LATER THAN May 1, 2010, for the Fall 2010 Semester.
2. If the Director of the Miss Fountain City Pageant does not receive any scholarship request in writing as specified above, **all money will remain in the MFC scholarship fund for future pageant winners.**
3. I understand that all scholarship monies won will be paid directly to my college or university. The acceptance letter required in Rule 1 should indicate the purser's office address of the college or university and should also indicate the student account number of the recipient. In no instance will the money be paid directly to the recipient. I understand that the University may disperse the funds upon receipt of payment, as the University sees fit. Many universities will divide the payment between semesters. The payment conditions will be worked out between the contestant and their school of choice.
4. I will have my college or university send enrollment verification to the Director of the Miss Fountain City Organization at the time I accept my scholarship award.
5. I understand that all scholarship awards to participants, other than the winner, will be available to be dispersed upon receipt of the acceptance letter from the recipient AND receipt of the enrollment verification from the recipient's college or university.
6. The winner's scholarship award(s) will be dispersed on the following schedule upon receipt of the acceptance letter AND receipt of the enrollment verification from the winner's college or university:
  - 50% within 4 weeks, prior to the pageant date.
  - 50% within 4 weeks following the 2010 Miss Alabama Pageant.
7. In the event that the winner is named Miss Alabama 2010, no successor will be named.
8. If the winner resigns, in good standing, from the position of Miss Fountain City 2010 prior to her appearance in the Miss Alabama pageant, she will forfeit any further scholarship winnings to which she would have been otherwise entitled. Her successor will be entitled to the winner's scholarship amounts not yet dispersed. If the winner resigns the position of Miss Fountain City 2010 after representing Prattville and Autauga County in the 2010 Miss Alabama Pageant, there will be no successor named and she will forfeit any remaining scholarship amounts to which she would have been otherwise entitled.
9. If the Director of the Miss Fountain City pageant due to a contract violation removes the winner from the position, she will forfeit all scholarship amounts awarded her by the Miss Fountain City Pageant during her tenure as Miss Fountain City. Any funds previously awarded her must be repaid to the Miss Fountain City Scholarship Fund.
10. I understand that it is the **sole responsibility** of Miss Fountain City 2010 to claim her Miss Alabama scholarship money in writing to Miss Alabama, as directed by the Miss Alabama Pageant. Information regarding the Miss Alabama Scholarship procedures for procuring the scholarship will be provided by Miss Alabama. The Director of the Miss Fountain City program will not be held liable for any loss of scholarship monies due to the error or lack of follow through by the reigning Miss Fountain City.
